- I understand the contents of the appointment of goods involving flight safety, security, fragile goods and airline rejection of delivery of goods, SPEX should be excluded from carriage.
 - I understand SPEX is only responsible for freight charge, if any additional charges incurred (such as export declaration charges, insurance, import duties, change the delivery address costs ... etc.), the additional burden is on their own.
 - I understand the information on the invoice should be declared true and non- hazardous materials or contraband, as a result of inaccurate reporting of the additional costs derived (e.g. withdrawal of charges , customs fines ... etc.), or shipments by customs seized, the unconditional support shall pay all costs and bear the relevant responsibility.
 - I shall be responsible for the proper packing of goods processing, such as the use of waterproof packaging or packaging of any goods due to damage caused by factors circumstances, SPEX will not bear the burden of any damage and value of the goods freight liability.
 - I understand the shipment invoice total imports to Taiwan more than NT\$3000, would impose import duty(other countries have different standards for transporting tax), the right to adjust the customs value of the goods, the amount of the final declaration is based on custom's decisions.
 - I understand one owned by the Taiwan law, the recipient/sender are required to sign full legal name at the time of receipt.
 - I understand the recipient must have a photocopy of the relevant documents and identity cards to the SPEX Taiwan clearance department to complete the clearance formalities. As a result, if the sender/recipient cannot meet the relevant provisions of that cargo causing pieces to not go through clearance, it is agreed to abandon this consignment handling with no objection.
 - I understand the following provisions if the contents of the goods sent to Taiwan include supplements or food:
 1. All supplements need to fill out the brand, contents, particle number or weight (total particulate grains not exceeding 1200, the total weight of liquid or powder not exceeding 10lb)
 2. All foods are required to fill out the brand, contents (total weight does not exceed 10lb)
 3. All supplements and foods units are required to be unopened. The product needs to include the ingredient label on the packaging that is FDA approved and may not be homemade food or include any herbs.
 4. All supplements and food are required to provide a photocopy of identity card for SPEX Taiwan customs department 5. All supplements must be accompanied by a photocopy of proof of purchase.
